December Skip-A-Pay Need Extra Dough for the Holidays?

Ask how you can skip your December 2018 loan payment(s) and free up extra cash for holiday spending. Hurry though! We must receive your completed and signed Skip-A-Pay form by 11/30/18.* Call 727.586.4422, visit a branch or download the Skip-A-Pay form online at www.pinellasfcu.org.

*A fee applies for each loan payment you elect to skip. Excludes accounts and loans that are past due or not in good standing, loans paid ahead more than 30 days, loans originated in November 2018 with first payment due in December 2018, first mortgage loans, Visa® credit cards and loans with active workout/hardship modifications. Your must make your regular November payment by 11/30/18 to skip the December 2018 payment. Interest continues to accrue during the month in which payment is deferred. Regular payments will resume on the following month's regular due date. If the loan(s) you elect to skip is/are paid biweekly, two biweekly payments will be skipped beginning with the first payment due during the month of December 2018. Loans with due dates beyond 12/31/18 will not be affected. Skipping a payment will extend the original loan maturity date. Skipping a payment and late payment fees will reduce the amount of a Guaranteed Asset Protection (GAP) claim. Please see your GAP policy for complete information. Other restrictions may apply. Offer ends and all enrollment forms must be received by 11/30/2018. Please retain a copy for your records.
